## Recognition as a Full-time Evangelist for Rebate Purposes

A recognized full-time evangelist is required to pay tithes to the District on his ministerial income. If the evangelist attends General Conference, 50% of his accrued tithing is returned to him two weeks prior to conference to assist in defraying expenses. An evangelist must attend conference to qualify for this rebate.

## Evangelist's Housing Allowance
